2. I will not violate any city, state, federal, or tribal law and will immediately notify my probation supervisor if I am arrested or have contact with any law enforcement agency.
3. I will not change my address or phone number without notifying my probation supervisor. I will allow my probation supervisor to visit me at my home or elsewhere.
4. I will neither have in my possession nor use any alcoholic or intoxicating beverages, marijuana, or any other illegal controlled dangerous substance, and be subject to drug testing at my expense.
5. I will maintain lawful, gainful employment and provide written employment verification to my probation supervisor as requested.
6. I agree to pay all court costs, fines, fees, and assessments accruing in this case to the Washington County Clerk, 1st Floor, Washington County Courthouse, 420 S. Johnstone, Bartlesville, Oklahoma 74003 (918) 337-2870.
7. I will pay restitution to the Office of District Attorney (at address above) pursuant to the Rules and Conditions of Restitution.
