Colloquy by Court with defendant regarding right to attorney, waiver of preliminary hearing as time limits were waived previously. There was an agreement between ADA Gunderson and defendant to reduction of Count 1 - felony to a misdemeanor. Court explained maximum penalties although not requested by the State.
