COUNT 1: ILLEGAL VOTING, a Class 5

COUNT 1

ILLEGAL VOTING

During a period beginning on or about October 7, 2020, and ending on or about November 3, 2020, **TRACEY KAY McKEE**, not being entitled to vote, knowingly voted, in violation of A.R.S. §§ 16-1016(1), 16-101, 16-1021, 13-701, 13-702 and 13-801.

Said conduct occurred when **TRACEY KAY McKEE**, voted the ballot of deceased elector [REDACTED] in the November 3, 2020, General Election in Maricopa County, Arizona.

COUNT 2

PERJURY

During a period beginning on or about October 7, 2020, and ending on or about November 3, 2020, **TRACEY KAY McKEE**, knowingly made a false unsworn declaration in regard to a material issue that she subscribed as true under penalty of perjury, believing it to be false, in violation of A.R.S. §§ 13-2702(A)(2), 13-2701, 13-701, 13-702 and 13-801.

Said conduct occurred when **TRACEY KAY McKEE**, knowingly signed the name of [REDACTED] to a declaration under penalty of perjury located on the November 3, 2020, General Election early ballot envelope for deceased elector [REDACTED]



above were committed in Maricopa County, Arizona.


