In Manatee County Larry Wiggins violated F.S.S. 104.047(1) Vote by mail ballots and voting violations. On September 17, 2020, the Manatee County Sheriff's Office was contacted by the Supervisor of Elections Michael Bennett reference to possible voter fraud. Mr. Bennett was notified by his employees that a request for a mail in ballot by Ursula Wiggins was confirmed through DAVID, a deceased person since September 17, 2018. The mail in request was dated September 3, 2020, and received by Manatee County Supervisor of Elections office on September 16, 2020. A verification check was conducted and after confirming Ursula Wiggins was deceased the handwriting from the Ballot request was compared to Ursula Wiggins voter's registration application, and they did not match. The elections office next conducted an address search and the address also came back to Larry Wiggins. The office then checked Larry Wiggins who had mailed in a request for a mail in ballot dated September 2, 2020 and received on September 11, 2020. The supervisor of elections compared the handwriting from Larry Wiggins request to his deceased wife's request and noticed similar handwriting.

Sgt. Hurd and I went to Larry Wiggins home located at 7351 West Country Club Drive #104 Sarasota, FL 34243. In a non-custodial interview, Mr. Wiggins admitted to requesting a mail in ballot for himself and his deceased wife Ursula Wiggins who had passed away on September 17, 2018. Mr. Wiggins stated he had heard on TV that there was voting fraud taking place and wanted to test the system. We showed Wiggins the actual voter request card mailed in and he admitted to filling out and forging his wife's signature on the request form. Wiggins also said once he received his wife's ballot he intended on mailing it in.

Based on the aforementioned facts there is probable cause to charge Larry Wiggins with Vote by mail ballots and voting violations.
