SENTENCING ORDER

On the 24th day of August, 2023, came the defendant, **JACK WILSON VAUGHAN**, together with his counsel, Dave Hendrickson, and also came the State of West Virginia by Jennifer D. Crane, Assistant Prosecuting Attorney in and for Kanawha County, West Virginia, by Microsoft Teams for the purpose of an arraignment and plea hearing.

Whereupon, the defendant entered a plea of guilty to illegal voting as set forth in this indictment, and he waived his right to a presentence investigation report. The Court, after a review of the entire file in this matter and upon hearing the argument of both counsel, finds that it has sufficient information about the defendant to proceed to sentencing without a presentence investigation report.

Upon defendant's oral and written plea of guilty to the misdemeanor offense of Illegal Voting, a provable offense as contained in misdemeanor Indictment Number 23-M-70, entered in this Court on the 24th day of August, 2023, with his counsel then present, it is the judgment of this Court that the defendant, **JACK WILSON VAUGHAN**, is guilty of Illegal Voting.

THEREUPON, it was demanded of the said **JACK WILSON VAUGHAN**, if anything he had or knew to say why the Court should not now proceed to pronounce the sentence of the law against him, and no valid reason being offered or alleged in delay of judgment, it is

CONSIDERED and **ORDERED** by the Court that the defendant, **JACK WILSON VAUGHAN**, be fined one hundred dollars (\$100.00) plus court costs.


