**INDICTMENT**

CHARGING VIOLATIONS OF:

**COUNT 1: ILLEGAL VOTING**, a Class 5  
Felony, in violation of A.R.S. §16-1016(1);

**COUNT 2: PERJURY**, a Class 4 Felony, in  
violation of A.R.S. § 13-2702(A)(2).

The 89<sup>th</sup> Arizona State Grand Jury accuses **KRISTA MICHELLE CONNER**,  
charging on this 25<sup>th</sup> day of October, 2021, that in or from Cochise County, Arizona:

**COUNT 1**

**ILLEGAL VOTING**

During a period beginning on or about October 7, 2020, and ending on or about November 3, 2020, **KRISTA MICHELLE CONNER**, not being entitled to vote, knowingly voted, in violation of A.R.S. §§ 16-1016(1), 16-101, 16-102, 16-1021, 13-701, 13-702 and 13-801.

Said conduct occurred when **KRISTA MICHELLE CONNER**, voted the ballot of deceased elector Caroline Jeanne Sullivan in the November 3, 2020, General Election in Cochise County, Arizona.

**COUNT 2**

**PERJURY**

During a period beginning on or about October 7, 2020, and ending on or about November 3, 2020, **KRISTA MICHELLE CONNER**, knowingly made a false unsworn declaration in regard to a material issue that she subscribed as true under penalty of perjury, believing it to be false, in violation of A.R.S. §§ 13-2702(A)(2), 13-2701, 16-102, 13-701, 13-702 and 13-801.

Said conduct occurred when **KRISTA MICHELLE CONNER**, knowingly signed the name of Caroline Jeanne Sullivan to a declaration under penalty of perjury located on the November 3, 2020, General Election early ballot envelope for deceased elector Caroline Jeanne Sullivan.


