INDICTMENT

CHARGING VIOLATIONS OF:

COUNT 1: FALSE REGISTRATION, a Class 6 Felony, in violation of A.R.S. § 16-182(A);

COUNT 2: ILLEGAL VOTING, a Class 5 Felony, in violation of A.R.S. §16-1016(1).

The 90th Arizona State Grand Jury accuses **ROBERTO GARCIA**, charging on this 22nd day of March, 2022, that in or from Pinal County, Arizona:

COUNT 1

FALSE REGISTRATION

On or about January 8, 2020, **ROBERTO GARCIA**, knowingly caused, procured or allowed himself to be registered as an elector of any county, city, town, district or precinct, knowing that he is not entitled to such registration, in violation of A.R.S. §§ 16-182, 16-101, 13-701, 13-702 and 13-801.

Said conduct occurred when **ROBERTO GARCIA**, knowingly completed a voter registration form which stated in pertinent part “I have NOT been convicted of a FELONY or my civil rights have been restored” when in fact he had been convicted of a felony, with his right to vote not having been restored after October 23, 2006.

COUNT 2

ILLEGAL VOTING

On or about November 3, 2020, **ROBERTO GARCIA**, not being entitled to vote, knowingly voted, in violation of A.R.S. §§ 16-1016(1), 16-101, 16-1021, 13-701, 13-702 and 13-801.

Said conduct occurred when **ROBERTO GARCIA** voted in the November 2020 General Election despite having had his right to vote suspended because of a felony conviction, with his right to vote not having been restored after October 23, 2006.



Pursuant to A.R.S. § 21-425, the Grand Jurors find that the offenses described above were committed in Pinal County, Arizona.


