On April 21, 2017, this case came on for hearing. The defendant was present and represented by his/her attorney, Kenneth Harbison, Corey Burns, D. Mitchell. The plaintiff was represented by E.F. Waterman, K. McBride, G. Goodwin, M. Neher. _____ . The certified interpreter was present, was sworn, and interpreted.

The defendant was advised of the following: nature of proceedings/presumption of innocence; possible penalties upon conviction; and right to require State to prove guilt beyond a reasonable doubt; rights to court-appointed attorney if indigent; right to speedy and public trial; right to confront and cross-examine all witnesses; right to testify in his/her own behalf; right to remain silent; right to use compulsory process; right to appeal court's decisions; () possibility that conviction for present offense may cause penalty enhancement in subsequent offense () if not a United States citizen, the possibility of deportation or denial of naturalization () necessity to register as convicted sex offender upon conviction () right of person under 18 years of age at the time of the offenses to request transfer to juvenile court jurisdiction () possible obligation to pay restitution upon conviction

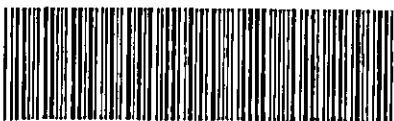
The defendant acknowledged his/her understanding of the rights, charges, proceedings, and penalties, and further acknowledged his/her understanding the entry of a plea of guilty or no contest waives all the above rights, except the right to counsel at all stages and the right to appeal. Defendant waived service of amended information and 24 hour waiting period. The () information amended information was read to the defendant and the defendant pleaded:

The court finds beyond a reasonable doubt that a factual basis was established for each plea of guilty or no contest. After further inquiry, the defendant acknowledged that his/~~her~~ plea/~~s~~ were/~~s~~ was not the result of any promise or threat. The court found that the defendant's plea/~~s~~ were/~~s~~ was entered freely, knowingly, voluntarily, and intelligently and that the defendant knowingly, voluntarily, and intelligently waived his/~~her~~ constitutional rights as hereinabove explained. The court accepted the defendant's plea/~~s~~ and found the defendant guilty beyond a reasonable doubt of each charge to which a plea of guilty or no contest was made and a judgment of conviction thereto was entered.

The State Probation Office shall conduct a Type I/II presentence investigation and make an appropriate report of all findings to the court. Said presentence investigation shall include: all standard and usual investigations and evaluations; restitution study; substance abuse and chemical dependency evaluation; sex offender evaluation; domestic violence evaluation other _____ The defendant shall submit to any testing required by the probation office, including any psychological testing and any testing of the defendant's blood, breath, or urine. The case is set for a sentencing hearing on _____, at _____m.

The defendant waived a presentence investigation report and requested an immediate sentencing. Statements were made and the defendant was given his right of allocution. The defendant was sentenced as follows: pay fine of \$ 100 pay costs payment of costs waived no jail (_____) days in the Dawson County Jail. The defendant's bond shall be applied to costs with the balance of the bond paid to the person who posted the bond. The defendant is given credit for _____ days served in the Dawson County Jail.

Pending a sentencing hearing, the defendant's prior bond is continued, with the additional condition that defendant cooperate with the probation office to complete the presentence investigation and _____
 Sentencing deferred. The defendant is admitted to the Midwest Nebraska Drug Court program and the defendant's bond is amended to require full compliance with and completion of such program.
