CRIMINAL COMPLAINT

AARON D. FORD, Attorney General for the State of Nevada, complains and charges that:

The above-named defendant, DONALD KIRK HARTLE, has committed the crime of VOTING USING THE NAME OF ANOTHER PERSON, a category "D" felony in violation of NRS 293.775 [58476]; and VOTING MORE THAN ONCE AT SAME ELECTION, a category "D" felony in violation of NRS 293.780 [52523].

All of the acts alleged herein have been committed or completed on or between October 26, 2020 and October 30, 2020, by the above-named defendant, within the County of Clark, State of Nevada, in the following manner:

COUNT 1
VOTING USING THE NAME OF ANOTHER PERSON
Category "D" Felony - NRS 293.775

Defendant, DONALD KIRK HARTLE, in the County of Clark, State of Nevada, did knowingly and feloniously vote using the name of another person, to wit: ROSEMARIE HARTLE.

COUNT 2
VOTING MORE THAN ONCE AT SAME ELECTION
Category "D" Felony - NRS 293.780

Defendant, DONALD KIRK HARTLE, in the County of Clark, State of Nevada, did knowingly and feloniously vote in the 2020 general election in Las Vegas, Nevada, having previously voted in the same election.

All of which is contrary to the form, force and effect of the statutes in such cases made and provided, and against the peace and dignity of the state of Nevada.

1 *The Complainant requests a Summons be issued at this time pursuant to NRS 171.106.*

2 That Complainant knows these crimes occurred and that the Defendant, DONALD KIRK HARTLE,
3 has committed these crimes because Complainant is a Senior Deputy Attorney General, and in possession
4 of a report of investigation that includes statements made by witnesses and other documentary evidence.

5 Said Complainant makes this declaration under penalty of perjury.
