the West Virginia Attorney General's Office was requested to assist, and Investigator Joseph Stiles began
looking into the matter. Investigator Stiles obtained information from the Monongalia and Marion County
Clerks' Offices confirming an individual with matching identifiers had, in fact, voted in both counties. On
Friday, May 5, 2017, Investigator Stiles met with the Defendant and informed him of the allegations. The
records demonstrate he registered on or about July 1, 2015, and again on or about July 22, 2015. The
Defendant admitted he used the process at the Department of Motor Vehicles (DMV), and also registered
using the online voter registration (OVR) feature to accomplish the dual registrations. The records indicate the
Defendant voted at the Smithtown Building in Monongalia County at 1:17 p.m., and later voted at the Eastdale
Elementary in Marion County. The Defendant admitted to double voting consistent with the records.
